# Contributions and admission fees

## Admission fees (one-off):

- Admission fee for adults: 25,- €
- Admission fee after participation in the taster course for adults: 25,- €
- Admission fee for pupils/youths: 15,- €
- Admission fee for inactive persons: 10,- €

## Contributions (monthly):

- Adults: 12,- €
- Pupils/youths: 7,-€
- Inactive members: 3,- €

## Family rate:

- First member: one active adult 12,- EUR per month.
- Second member: an adult or a pupil/young person pays only 2/3 of his/her actual fee.
- Each additional member: a pupil/young person pays only half of his/her actual contribution.

In the case of simultaneous new registration in the family tariff, the admission fee of EUR 25.00 will only be charged once.

The membership fee in the year of admission is calculated pro rata from the 1st of the month following the month of admission.

The membership fee shall be paid annually in advance by 31 January of the respective financial year, as this is when the Association incurs its greatest financial obligations. Each newly admitted member shall pay an admission fee.

Resignation can only be made in writing at the end of the current business year, electronic form is excluded. Resignation must be declared by 31 December of the year at the latest. Decisive for this is the date of receipt of the written notice by the Executive Board in accordance with § 10 No. 2. of the Association's Statutes.

For the business year in which the notice of resignation is given, the full membership fee is still payable.
